Section 2. Tract B has been subdivided and replatted into the following five (5) lots:

Lots B-1, B-2, B-3, B-4 and B-5, EAGLE ESTATES, according to the official plat thereof, filed under Plat No. 2008-175, records of the Fairbanks Recording District, Fourth Judicial District, Stale of Alaska.

<u>Section 3.</u> The withdrawal of Lots B-2, B-3, B-4 and B-5 from the Common Interest Community and the jurisdiction of the Declaration for Eagle's Nest Condominiums was approved by all Unit Owners in Eagle's Nest Condominiums by Resolution dated June 15, 2006.

If any term, covenant or condition of this Amendment is held to be invalid or unenforceable in any respect, such invalidity or unenforceability shall not affect any other provision hereof and this Amendment shall be construed as if such invalid or unenforceable provision had never been contained herein.


